**ORDINANCE OF THE TOWNSHIP OF HADDON,
COUNTY OF CAMDEN, STATE OF NEW JERSEY
SUPPLEMENTING, AMENDING AND REVISING
CHAPTER 223, OF THE CODE OF THE TOWNSHIP OF
HADDON ENTITLED “VEHICLES AND TRAFFIC”.**

WHEREAS, The Township of Haddon (“Township”) is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

WHEREAS, pursuant to N.J.S.A. 39:4-8 and N.J.S.A. 39:4-197 municipalities are authorized to designate one-way streets and prohibit or restrict general parking; and

WHEREAS, based upon the advices of the Township Engineer and Chief of Police, the Governing Body has deemed it in the best interest of the public health, safety and welfare to supplement, amend and revise its Traffic Ordinance as codified in Chapter 223 of the Township Code;

NOW THEREFORE, BE IT ORDAINED by the Mayor and the Board of Commissioners of the Township of Haddon, County of Camden, State of New Jersey, as follows:

SECTION 1: Section 223-26 entitled “One-Way Streets” is hereby amended to include the following:

| Name of Street | Direction | Limits | Parking Permitted |
|-----------------------|------------------|---|---|
| Glenwood Avenue | Southwesterly | From a point 200 feet southwest of Haddon Avenue to Atlantic Avenue | Both, except as prohibited by Section 223-13 and as restricted by Section 223-15B |

SECTION 2: Section 223-13 entitled “Parking Prohibited At All Times on Certain Streets” is hereby revised as follows:

| Name of Street | Side | Location |
|-----------------------|-------------|--|
| Glenwood Avenue | Southeast | From Haddon Avenue to Ardmore Avenue |
| Glenwood Avenue | Northwest | From Haddon Avenue to a point 200 feet southwest thereof |

SECTION 3: Section 223-15B entitled “Parking Permits; Permit Parking During Certain Hours on Certain Days on Certain Streets,” is hereby amended to include the following:

| Name of Street | Location | Hours | Days |
|-----------------------|--|------------------------|--|
| Glenwood Avenue | Southeast side for the seven (7) parking spaces in the bump-in | Twenty-four (24) hours | Three hundred sixty-five (365) days per year |

SECTION 4: Except as set forth in Sections 1, 2 and 3, the balance of Chapter 223 shall not be affected by this Ordinance.

SECTION 5: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 6: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 7: This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
