ORDINANCE OF THE TOWNSHIP OF HADDON, COUNTY OF CAMDEN AND STATE OF NEW JERSEY, AUTHORIZING THE LEASE OF CRYSTAL LAKE POOL CONCESSION STAND

WHEREAS, there exists at the Crystal Lake Pool a municipally owned concession stand;
and

WHEREAS, the Township of Haddon desires to lease the concession stand to the highest bidder in accordance with the terms and conditions of the Local Lands and Buildings Law, N.J.S.A. 40A:12-1, *et seq.*; and

NOW THEREFORE, be it Ordained by the Board of Commissioners of the Township of Haddon, County of Camden, State of New Jersey, as follows:

SECTION 1: The execution of the lease agreement attached hereto as Exhibit “A” between the Township of Haddon and the highest qualified bidder, F&J Joint Ventures, LLC (“Lessee”) to operate the Crystal Lake Park Concession Stand is hereby authorized.

SECTION 2: The term of the lease agreement shall be from Memorial Day to Labor Day, 2010, at a rental of \$3,500.00 for the term.

SECTION 3: The purpose of the lease agreement is to provide for the preparation and sale of food, beverages and other refreshments to uses of the Crystal Lake Pool.

SECTION 4: The Mayor, Township Clerk and any other appropriate Township employee or elected official are hereby authorized and directed to enter into the aforementioned lease agreement and execute all other documents as may be required or appropriate to accomplish the above purpose, subject to the Township Solicitor reviewing and approving the form and content of same.

SECTION 5: All Ordinances or parts of Ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 6: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 7: This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
