There being no further business on the agenda, Commissioner Foley moved to open the meeting to the public, seconded by Commissioner Dougherty, with all members voting in the affirmative.

John Kendall, 120 Washington Avenue – Mr. Kendall inquired about the Corrective Action Plan. Mayor Teague responded that the Corrective Action Plan identifies items in the Audit that need to be corrected. The Township then makes recommendations on how to correct those items, which the governing body must therefore approve. Mr. Kendall inquired about the accelerated tax sale. Mayor Teague responded that the accelerated tax sale happens at the end of every year, and has taken place for the last 5 years, or there about. Mayor Teague stated that the purpose of the sale is to realize tax revenue for the current year which allows the Township not to budget monies in reserve taxes, and allows realization of tax revenue in the same year. Mr. Kendall inquired about decorations in the Heights to which Mayor Teague responded that he spoke to Kate Burns who in turn, contacted Mr. Stevenson. Superintendent Stevenson said that the poles for decoration would have to be used on Nicholson Road, and that the Township would need permission to do so-which is a start. Mr. Kendall reported that he spoke with Mr. Palo about the ongoing situation with two businesses in West Collingswood Heights. Mr. Kendall briefly discussed the Turkey Trot with the Board of Commissioners. Mr. Kendall mentioned the concerns of a resident named Dave Woloszyn of Grandview Avenue in the Heights regarding potholes on his street and elsewhere in his area. According to Mr. Kendall, Mr. Woloszyn believes that since the town receives revenue from the cell tower near his residence that some of those funds could be used to fix up that area of town. Mr. Kendall also mentioned a flooding problem at Ohio & Wilson Avenues. Mr. Kendall reported that Crew would be announcing the winner of the Crew Fundraiser at the Festival of Lights. Mr. Kendall ended by saying he would be acting

in a play at Rutgers, 12 Angry Jurors, and may not be present around town as much due to rehearsing.

Mayor Teague announced that the Commissioners are cancelling the Commissioners Meeting scheduled for December 27th and combining it with the Caucus Meeting on December 20th. Mayor Teague reported that this would be the final meeting of 2016.

Commissioner Foley wished everyone in Township a Happy Thanksgiving on behalf of Mayor Teague, Commissioner Dougherty, the entire staff, administration, and himself.

There being no further comments, Commissioner Foley moved to close the meeting to the public, seconded by Commissioner Dougherty, with all members voting in the affirmative.

There being no further business to discuss, Commissioner Foley moved, seconded by Commissioner Dougherty that the meeting be adjourned at 7:17 PM, with all members voting in the affirmative.
