

**ORDINANCE #1386**  
**OF THE TOWNSHIP OF HADDON, COUNTY OF CAMDEN, AND STATE OF NEW**  
**JERSEY, AMENDING, REVISING AND SUPPLEMENTING SECTION 223-19,**  
**ENTITLED “LOADING ZONES,” OF CHAPTER 223, ENTITLED “VEHICLES AND**  
**TRAFFIC,” OF THE CODE OF THE TOWNSHIP OF HADDON**

**WHEREAS**, Section 223-19, entitled “Loading Zones,” of Chapter 223, entitled “Vehicles and Traffic,” of the Code of the Township of Haddon designates certain locations as special purpose loading zones and prohibits parking of a vehicle during the times indicated other than for the loading or unloading of goods and materials; and

**WHEREAS**, pursuant to N.J.S.A. 40:48-2, the Governing Body is authorized to enact and amend ordinances as deemed necessary and proper for the good government, order and protection of persons and property, and for the preservation of the public health, safety and welfare of the Township and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Township by law; and

**WHEREAS**, the Governing Body has deemed it in the best interest of the public health, safety and welfare to amend Section 223-19 of Chapter 223 of the Township Code.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Commissioners of the Township of Haddon, County of Camden, State of New Jersey, as follows:

**SECTION 1:** Section 223-19, entitled “Loading Zones,” of Chapter 223, entitled “Vehicles and Traffic,” of the Code of the Township of Haddon is hereby amended as follows:

The following locations are hereby designated as loading zones. No person shall park a vehicle in said location during the times indicated other than for the loading or unloading of goods and materials.

<u>Name of Street</u>	<u>Time</u>	<u>Side</u>	<u>Location</u>
Belmont Avenue	All	East	From a point 35 feet north of the northerly curbline of Cuthbert Road to a point 125 feet north thereof
Strawbridge Avenue	6:00 a.m., to to 2:00 p.m. except Sat. and Sun.	West	From the intersection of the curbline with Haddon Avenue to a point 80 feet north of Haddon Avenue

**SECTION 2:** Except as set forth in Sections 1 above, the balance of Chapter 223 shall not be affected by this Ordinance.


**SECTION 3:** All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

**SECTION 4:** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

**SECTION 5.** This Ordinance shall take effect upon passage and publication according to law.


