**ORDINANCE #1400 OF THE TOWNSHIP OF HADDON, COUNTY OF CAMDEN, AND
STATE OF NEW JERSEY, AMENDING, REVISING AND/OR SUPPLEMENTING
CHAPTER 223 OF THE CODE OF THE TOWNSHIP OF HADDON ENTITLED
"VEHICLES AND TRAFFIC"**

WHEREAS, Chapter 223 of the Code of the Township of Haddon ("Township") governs the operation and movement of vehicles and traffic within the Township and/or upon and about the public streets within the Township municipal borders, including the imposition of certain restrictions regarding on-street parking upon said public streets; and

WHEREAS, Section 15 of Chapter 223 establishes permitting requirements for parking on certain public streets within the Township as described therein; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the Governing Body is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Township by law;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Board of Commissioners of the Township of Haddon, County of Camden, State of New Jersey, as follows:

SECTION 1: Section 223-15 of the Code of the Township of Haddon, entitled "Parking Permits; Permit Parking During Certain Hours on Certain Days on Certain Streets" is hereby amended, revised and/or supplemented as follows:

A. Parking Permits. [NO CHANGE]

B. No person shall park a vehicle on the following streets or parts of streets unless an appropriate and current parking permit, as issued by the municipality, is displayed on said vehicle for the appropriate street or part of a street as described or listed below:

SECTION 2: Except as set forth in Section 1 above, the balance of Chapter 223 shall not be affected by this Ordinance.

SECTION 3: All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

SECTION 4: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 5. This Ordinance shall take effect upon passage and publication according to law.
