A Presentation by the Haddon Township Police Department regarding:

1) A proposed updating and overhaul of the Haddon Township Police Department's Policy and Procedures, by The Rodgers Group.

Presented by Lt. Colonel Frank Rodgers to the Commissioners with the following options:

- (A) Policy & Procedures Manual plus accreditation in the amount of \$39,900.00 and a yearly maintenance fee of \$6,200.00; or
- (B) Customized Development of Policy Development in the amount of \$27,500; and
- (C) Power DMS is the amount of \$3,921.34.
- 2) The purchase and implementation of a new Records Managements System, by Computer Square Incorporated.

Presented by John Denmark, Retired Law Enforcement. Cost is \$57,500.00 and the annual maintenance fee of \$7,850.00. Mr. Denmark mentioned the one time free to the Borough of Bellmawr for Shared Services for the Server in the amount of \$6,000.00.

Commissioner Mulroy moved to approve Option A, Haddon Township Police Department, Policies & Procedures by Rodgers Group in the amount of \$39,900 to be paid over 12 months at \$3,325.00 per month, plus the additional \$3,921.34 for Power DMS, seconded by Mayor Teague. All ayes.

Mayor Teague reported that the annual fee each year will be approved through the budget process.

Commissioner Mulroy moved to approve purchase and implement RMS by Computer Square, Inc. with the startup amount of \$57,500.00, seconded by Commissioner Linhart. All ayes.

Commissioner Mulroy instructed the Chief & Lieutenant that he would need updates on the implementation of the program so that he can report back to the Board of Commissioners.
