PUBLIC COMMENTS:

Mayor Teague reported that the Municipal Budget will be introduced next month with no tax increase.

There being no further business on the agenda, Commissioner Mulroy made a motion to open the meeting for public comment; seconded by Commissioner Linhart, with all members affirmatively concurring:

Gwenne Baile, 24 Hampton Road – Mrs. Baile reported on a topic she previously brought up which is extending the months to pick up yard waste for composting. She stated the weather is beautiful right now and many residents are gardening and it doesn't make sense to have the yard waste going to the incinerator or the landfill. Mayor Teague responded that certain times of the year the yard waste is removed by the Township's Trash Contractor and other times it is done by Public Works. In both instances, the yard waste is taken to the composter. Mayor Teague responded that we all need to work together. He further stated we can let the trash company know not to take yard waste, the Township needs to do a better job of publicizing, and the residents need to do better. He said the best way to put yard waste out is in brown paper bags.

Suzanne Ficara, 109 Cooper Street – Ms. Ficaro reported on TNR. She stated since September, 2020, the funds for TNR that were provided to Homeward Bound through grants and County money is gone. She reached out to Jill Rollins and Ms. Rollins said she was working on getting grants but she was not sure about County money. Ms. Ficaro asked the Mayor & Commissioners to reach out to the County Commissioners on their behalf. She reported that currently the charge is \$35.00 per cat, but previously it was 100% covered by the grants. It's not free to Senior Citizens. Ms. Ficaro stated that there was an Article about John's Friendly Market in the Retrospect and her sister was interviewed. Her sister does TNR for Mt. Ephraim. Commissioner Mulroy requested more information so they could provide it to the County.

Lawrence Richio, 50 Addison - Mr. Richio reported that he moved to Haddon Township in 1988 from South Philly. He came to the meeting tonight to discuss trees in his area. He reported that 1 of 5 trees were planted by the Township. He reached out to Chris Squazzo who told him the Shade Tree removes dead trees first and then trees that are near the wires. He reported that part of the solar panels are being blocked. Mayor Teague responded that Chris Squazzo is the Chairman for the Shade Tree Commission and the Township does not get involved with trimming trees near wires that it is PSE&G's responsibility. Mr. Richio M03232021

further reported that he spoke to Betty Brookes and she said it was a Verizon Truck in the area and they were checking for termites in the poles. He was concerned that they may have damaged his sprinklers and he wanted to know who to reach out to in that case. Mayor Teague asked that he reach out to both the Township and Verizon, since it will be Verizon's responsibility if they damaged his sprinklers.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.

There being no further business to discuss, Commissioner Mulroy moved, seconded by Commissioner Linhart that the meeting be adjourned at 7:28 PM, with all members voting in the affirmative.
