## BUSINESS

<u>Tree Tenders:</u> John Nystedt explained duties of tree tenders to include pruning and removal of ivy. John discussed Municipal overview for liability for volunteers. Also discussed was training for volunteers through the New Jersey Tree Foundation and if CEU's would be earned. Chris said he would talk to the Township's Solicitor to find out if there is liability coverage for the volunteers. John will set-up the tree tenders. Renee also knows someone interested in joining the tree tenders. Marge Howley added it would help for the new trees to be trimmed. Lauren asked about ivy on personal property trees. It was explained the Shade Tree Commission only has jurisdiction over curb trees and township property trees. Marge discussed educating the public via Facebook. John said he has already seen information on Facebook regarding removing ivy from trees.

<u>Spring 2021 Planting, Mitigation Trees and BID Trees</u>: Marge Howley, project manager for tree planting, did excellent work managing the selection, purchasing and planting of 103 new curb trees. Renee will assist Marge with the 2022 tree planting. Marge will give a condensed version of the species of trees planted to be posted on Facebook.

<u>BID Trees</u>: Renee will work as liaison with Kate Burns, BID Director, to manage the planting of trees in the Business District and Haddon Township open space areas.

## Annual Accomplishment Report/CORE/Tree City USA: Tabled

<u>Town-wide Maintenance Prune Contract</u>: John Nystedt has completed pruning bid spec. Chris will set-up a meeting with Mayor Teague.

<u>Tree Inventory</u>: John Nystedt reported the excellent work Jim Rhodes and his team have completed with Gov Pilot. An app was set-up to identify tree species. John will be providing the list of species for the app. Chris said there are only 8 to 10 species of trees planted prior to the establishment of the Shade Tree Commission. The new variety of species are from the STC's plantings.

<u>Review of STC Forms</u>: Renee suggested this be added to a work session.

<u>CEU'S FOR 2021</u>: Chris wants to have a group class for training/CEU's. He is reaching out to Brial Hotsko, PSE&G, to present class on Fungi. Other suggestions for classes would be for Tree Tenders. Marge has 2 CEU's waiting for approval.
