Report from Chicken Advisory Committee Chair:

Susan Passante, 14 Hampton Road – The following is the report as presented by Ms. Passante, Chair of the Chicken Advisory Board -This is the annual report for 2020 Chicken Advisory Board. The Program continues to thrive with the support of Mayor Teague, Commissioner Mulroy, Commissioner Linhart and Dawn Pennock. There are currently 91 hens within 22 households. This represents a 14% increase in hens over the course of 2020. Average hens per household is 4. During the year a few households decided not to renew due to illness and relocation. We had two new participants in the class in May. In January 2020, we ran a campaign to remind participants to renew their licenses. For 2021, this year, we fell behind, and we did not get our licenses renewed by the February 28th cutoff. However, as of today, all our 22 households are renewed and we'll make a commitment that in the Fall we will start this a lot earlier so that we don't have all this backlog and create all this work for Dawn and a lot of unnecessary email. Also due to the pandemic, the required class, Raising Back Their Chickens in the Suburbs was converted to a virtual format, participants were given an online test to pass in order to obtain their Certificate of Completion and

this program which was developed by Gwenne is offered to not only Haddon Township but our surrounding towns. The Board received a single complaint submitted to Haddon Township Compliance Officer in late March 2020. A member of the Board, myself, performed a site inspection of the property along with the chicken owner. No violations of the Ordinance were found. In April 2020 results of the site inspection were reported back to the Compliance Officer. The complaint was deemed to be unfounded. There have been no other complaints since the program started in 2015. We have our assignments each month, a board member is responsible to be on call should there be any complaints. Due to the pandemic, the Board held a virtual meeting in April and October, and we invite program participants, which is nice. The next board meeting was April 19th, we had that program, participants are invited along with Commissioner Mulroy and we invite the Oaklyn Group to participate with us. The Board will continue to monitor guidelines from meeting in person, the full meeting will be October 19th, it will either be virtual or at the Environmental Center. The Pandemic prevented our participation in the Block Party, although we look forward to these events returning and participating in the future. So, in October, we had our Board Elections, for 2021, but just recently our former Chair, Deborah Crabtree had to resign and on April 19th, we elected our new Board Members. Ms. Passante names the members of the Board as they appeared in tonight's Resolution.

PUBLIC COMMENTS:

There being no further business on the agenda, Commissioner Mulroy made a motion to open the meeting for public comment; seconded by Mayor Teague, with all members affirmatively concurring:

John Kendall, 120 Washington Avenue – Mr. Kendall came to the meeting to discuss the potholes in the West Collingswood Heights area, specifically on Delaware and New Jersey Avenues. He mentioned an area near the cell tower where two new houses were built that needed paving. Mr. Fusco advised Mr. Kendall that the developer of those houses is responsible for the paving, not the taxpayers. Mayor Teague responded that the Township would look at the potholes. The Mayor stated that the Engineer and DPW evaluate the streets and the worse potholes get done first. Mr. Kendall also inquired about the possibility of a Senior/Community Center in Haddon Township. Mayor Teague responded that if there were a Community/Senior Center, it would have to be a joint venture between the Board of Education and the Township and neither have the funds for that type of project. Mayor Teague pointed out that it's not just about the acquisition of a Community Center but the maintenance, utilities, upkeep, and personnel. If further stated that the Township has an affordable housing obligation and that it the Township's number one priority that will be costly for the Township. Commissioner Mulroy pointed out that Betty Band does a lot of events with the Senior Citizens in town and specially mentioned, Holy Savior, the Audubon Park Gala around Christmastime, and Bingo. Commissioner Linhart agreed that affordable housing is a priority, real estate is not easily obtainable, and that the Community Center requires costs in perpetuity, not just acquisition costs. Mayor Teague further pointed out that many residents are struggling due to the pandemic and cannot afford the cost of a Community Center.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.
