PUBLIC COMMENTS:

There being no further business on the agenda, Commissioner Mulroy made a motion to open the meeting for public comment; seconded by Commissioner Linhart, with all members affirmatively concurring:

John Kendall, 120 Washington Avenue – Mr. Kendall attended the meeting this evening to discuss the affordable housing obligation in Haddon Township. He asked about the Township's obligation, whether that obligation was for apartments or single-family homes, whether it was State mandated and asked if commercial property can be rezoned for housing. Mayor Teague informed Mr. Kendall that the obligation was 63 + 12 +15 units, those units will be apartments, it is court mandated and commercial property can be rezoned for housing. The Mayor stated the Township is looking for standalone units. Mayor Teague continued by explaining that every 10 years there is an affordable housing obligation, in which a number is negotiated and Senior Housing doesn't account for much and this is a result of the lawsuit filed against the Township by Fair Share Housing. Mayor Teague explained that the Township would have to find space for stand-alone and that has to be done through a tax credit program which is a very competitive process throughout the entire State. Mayor Teague reported that the State looks for certain criteria and the Federal Government looks for certain criteria to file for these federal tax credits. The Mayor explained that one of those requirements is that the development needs to be near public transportation. The Mayor further explained that the municipality must provide the donation, which is the space, then find a developer to develop the space and then the developer would file for tax credits to fund it. The Township is looking for the best opportunity to score high in an area that the affordable housing will fit which must be near public transportation. Mr. Kendall wanted to know what happens if we don't? The Mayor responded that it will be mandated by the Court and they will require us to find it somewhere or they will open it up to anyone and they will decide.

Jennifer Lehman, 367 Nicholson Road – Ms. Lehman came to the meeting to discuss the trash/recycling in her area of West Collingswood Heights. Mayor Teague explained the Township has a contract with South Jersey Sanitation and they are having issues with employees which is causing a delay with the trash pick-up. The Mayor reported that the Township is trying to get it resolved the best we can. The Mayor reported that this issue has been going on for quite a while and the last month or two it has been getting worse. The

Mayor continued by saying Township goes out to bid around every 5 years and goes with the lowest bidder, and they've always done a good job; there are not a whole lot of companies out there that provide this service. The Mayor explained there are options in the contract for brush entire year or part of the year or Township could get a brush truck. The Township did get a brush truck because it was the most economical thing for us to do. The Township does use their trash truck for brush and the Township has been helping with brush pick up. As far as the Township getting into the trash business, it's too expensive. He further explained that the Township has been working with the trash company. At this point the Township does not need to notify them of breach of contract. Ms. Lehman said she called public works and Betty called her back right away. She said Betty informed her that an Emergency Contract can be signed with another company to supplement service. Mr. Stevenson pointed out the Township did not sign a contract with another company, South Jersey Sanitation signed the contract with another company. Mayor Teague reaffirmed what Mr. Stevenson explained. Ms. Lehman wanted to know when it would be considered breach of contract. Mayor Teague responded that we will know when we get to that point.

Morris Cooperman, 44 Lindisfarne Avenue – Mr. Cooperman came to the meeting this evening to discuss areas of issue on Lindisfarne, the first being rats. Mayor Teague responded that the Township received notice that one of the neighbors had a sewer leak. That individual has been ordered to have it repaired. Mr. Cooperman said the neighbor said he got an exterminator. Mr. Cooperman said when he spoke to the Camden County Board of Health, he was told that a minority contributor was a restaurant. Mayor Teague reported that the Compliance Officer notified the owner of the plaza and the restaurants. Mr. Cooperman suggested that they look at the size of the dumpster; they may need a larger dumpster. Mayor Teague stated the same issue was down the street not too long ago. The Mayor further explained that to resolve the issue, it takes a combination of efforts; all entities must work together. Mr. Cooperman informed everyone that the Camden County Board of Health told him that residents should be made aware that dog waste, standing water and wood piles attract rats. Mayor Teague replied that when the issue down the road existed, the Township did send a notice. Mr. Cooperman stated he just wanted to make sure that reasonable steps were being taken to address the issue. The discussion moved on to trees. Mayor Teague commented to Mr. Cooperman that he remembers him from a previous meeting when he discussed the discovery of a rare tree. Commissioner Linhart asked if he reported that discovery to the Shade Tree Commission. Mr. Cooperman discussed a dead tree on Atlantic Avenue when he first moved in. He stated that Tom Cello from Public Works said he would come out and take it down and he did. Mayor Teague explained to Mr. Cooperman that if someone reports a dead or dying tree to the Township, the Shade Tree will assess the tree and go back to Public Works to have it trimmed or removed. Mr. Cooperman asked Mayor Teague if we have the ability to discuss issues with Patco. He stated outside the fence behind his property there is a lot of growth on other side of the fence. Mayor Teague asked Jim Stevenson to reach out to Patco. Mr. Cooperman asked the Mayor if he thought they should get an exterminator even though they don't have rats. Mayor Teague responded in the affirmative so that he could prevent his property from getting rats.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.
