This Contract runs through the end of 2025. As with most contracts, no one got everything they wanted but I think it's a fair contract for both sides. By agreeing to this Contract, both sides avoid the cost of hiring attorneys, engaging in extensive litigation, and conducting mediation hearings.

Contract Negotiations are always a collaborative effort. I would like to thank Officer Casey and his team for bargaining in good faith to reach this agreement. I would also like to thank Betty Band, Dawn Pennock and our Labor Counsel, Mike DiPiero, for their work on the Township side.
