PUBLIC COMMENT

There being no further business on the agenda, Commissioner Mulroy made a motion to open the meeting for public comment, seconded by Commissioner Linhart, with all members affirmatively concurring:

Mr. Tony Black, Maple Avenue, Haddon Township – Mr. Black stated he is a resident of Haddon Township and went to Haddon Township Schools. He is 71 years old. His parents moved to Maple Avenue in 1959 when he was eight years old. Haddon Township and Haddon Township Schools have been really good to him and they have been instrumental in him having the opportunity to be successful in the racing industry, thanks to some of the teachers and the administration there. He reported that he still lives on Maple Avenue, 5 doors down from the house he grew up in. He reported that his mom still lives there and she's 97 years old. Mr. Black noticed that Maple Avenue is a street that people have no respect for the speed law. The speed limit is 25 mph and Maple connects Haddon Avenue to Grove Street, Kings Highway and Route 70. People want to get to Route 70 as fast as they can. He spoke to the County Highway Department and at one point they put speed bumps on Maple Avenue that worked, but they were cut down because Maple Avenue is a County Road that is used by Emergency Vehicles and you can't have speed bumps on a road that has Emergency Vehicles. Mr. Black asked the County who has the jurisdiction to slow some of these people down. He has a disabled child that goes to St. John of God and she gets bused there which is a school for disabled children. Mr. Black watched the lady that drives the bus put the lights on and there will be two or three cars that stop and maybe someone in the fourth car back, just goes around them. Mr. Black stated, that when he took his driver's test, you stopped for school buses. When he spoke with the County Highway Department they stated, Maple is a County Road but the jurisdiction for speed limits and law enforcement falls on Haddonfield and Haddon Township. The ladies in the Tax Office told him there was a Board of Commissioners meeting tonight and he thought maybe he could bring it to someone's attention. Mr. Black feels that even the visibility of a police car, or someone patrolling, or just someone sitting in a police car on Marne Avenue on the side street; if they saw a police car they would slow down. Even on Grove Street, they have police cars, he thinks it is Cherry Hill, people have slowed down on Grove. Mr. Black stated "maybe if I said it here, the right person would hear it". Mr. Black reported, that there are kids riding bikes to school. There is a pedestrian crosswalk. Mr. Black reported that apparently you don't have to stop for anything on Maple. We have a lot of foot traffic going to the high-speed line. Mr. Black would like someone to get proactive and not reactive. Mayor Teague responded that we have our Chief and Captain here and they can come up with something to address this issue and the police can work with Haddonfield. Captain Hak said the Township did a traffic study one time there for a different reason but he will take a look at it and the police will be proactive. Captain Hak reported the Police have a speed trailer they can put out there and sometimes Maple is a little difficult you only see a police officer on one side of the road when they are running radar. Captain Hak stated the Township has the same concerns. Commissioner Mulroy asked if there is a particular time of day that you notice it. Mr. Black responded when people are going to work and coming home from work.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.

Commissioner Linhart that the meeting be adjourned at 7:19 PM, with all members voting in the affirmative.
