Michelle Ayers, Haddonview Apartments – Ms. Ayers came to the meeting tonight as a 12-year resident of Haddonview Apartments. She read an article in The Retrospect that caused her to have concerns about how the rent increases were calculated by the Secretary of the Rent Control Board. She also had concerns about the article in The Retrospect regarding the statement made by the Solicitor that the differences in indexes used are insignificant. She believes that each tenant will be out of pocket about \$500 due to the index that was used and that is not insignificant. She asked the Mayor and Commissioners to check into this issue. Mayor Teague responded that the Township would check.

Timothy Hinton, Rutgers University Law Student, Cuthbert & Stokes Avenue – Mr. Hinton encouraged the Board of Commissioners to look back over prior years of rent increases, Philadelphia and NY CPI and see the differences and see if those differences can be addressed. Mayor Teague reiterated that the Township would look into this issue.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.
