PUBLIC COMMENT

There being no further business on the agenda, Commissioner Mulroy made a motion to open the meeting for public comment, seconded by Commissioner Linhart, with all members affirmatively concurring:

Suzanne Passante, Chair of the Chicken Advisory Board – Ms. Passante reported that she is required to give a report once a year and she extended her thanks to Mayor Teague, Commissioner Mulroy, Commissioner Linhart, Dawn Pennock and Lee Palo for helping them throughout the year. She stated that they just finished their 7th year. She reported that there are 103 hens in 27 households. Since they started it has fluctuated between 24 to 27

households out of 30 licenses. They are currently at 27 households. She reported that everyone is compliant and that is quite an accomplishment. She further stated that she received no complaints in 2022. They established on call assignments for members of the Chicken Advisory Board and the members take turns in case something comes up that needs to be addressed. They have two meetings, starting with April 17th. She reported that they are back at the Environmental Center but they are still doing hybrids and Mr. Palo will be invited as their Liaison. Ms. Passante hopes to participate in the Pride Parade again this year and to see if they can participate in the Block Party. She will encourage hen holders to be part of that event. She finally reported that they held their elections and the members are as follows: She is the Chair, Marge Howley is the Vice Chair, Lauren Nasto is the Secretary, Gwen Baile is the Chair Emeritus, and members, Steve Balogh, Jamie Gusrang, Jim Nasto, Michael McHale, and Robert Tyrrell.

Mayor extended his thanks to Suzanne and the committee for making this a successful program. Commissioner Mulroy responded that he has not received any complaints and asked what makes this so successful. Suzanne contributed most of the success to the training provided by Gwen Baile.

Susan Ficaro, 109 Cooper Street – Ms. Ficaro reported that at the corner on Cooper and Emerald, there was a street sign that blew down last March in a wind storm. She reached out to DPW and they came out and picked it up. She further commented that she thought it would be replaced but as of today there is no sign. The Mayor responded that the Township will take care of it. Ms. Ficaro asked who the new Animal Control Officer/New Organization is for the Township. The Municipal Clerk responded NJ Animal Control. Ms. Ficaro then asked for the name of the Executive Director and the Municipal Clerk responded that she would provide her with that information Ms. Ficaro raised her concerns about issues with Homeward Bound that is causing them to raise their prices for communities that bring their animals to the Shelter. She is concerned that the TNR Program will be affected due to these changes. She reported that they can get services for \$40.00 and she doesn't want to lose those services. Her concern is that we will change shelters due to costs. Mayor Teague responded that we would have to find information out and then evaluate those rates; it doesn't mean we have to change shelters. Ms. Ficaro informed the Board that the new Executive Director is Ken Serianski. She stated she contacted him by email but he has not responded. Ms. Ficaro said AWA has a feral mash clinic and it costs \$20 for the same services but they only have them every 3 months and there is no limit.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.

There being no further business to discuss, Commissioner Mulroy moved, seconded by Commissioner Linhart that the meeting be adjourned at 7:12 PM, with all members voting in the affirmative.
