

**ORDINANCE #1440**

**ORDINANCE OF THE TOWNSHIP OF HADDON, COUNTY OF CAMDEN, AND  
STATE OF NEW JERSEY AMENDING AND REVISING CHAPTER 54 OF THE CODE  
OF THE TOWNSHIP OF HADDON ENTITLED “POLICE DEPARTMENT”**

**WHEREAS**, Chapter 54 of the Code of the Township of Haddon (the “Code”), entitled “Police Department,” regulates the operation of the Haddon Township Police Department; and

**WHEREAS**, Section 33 of Chapter 54 regulates the hourly rate for extra-duty assignments of Township Police Department personnel; and

**WHEREAS**, the Governing Body desires to revise the rates set forth in Chapter 54, Section 33 in an effort to increase security at Haddon Township Board of Education Events; and

**WHEREAS**, pursuant to N.J.S.A. 40:48-2, the Board of Commissioners is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Township by law.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Board of Commissioners of the Township of Haddon, County of Camden, State of New Jersey, as follows:

**SECTION 1:** Chapter 54, Section 33 of the Code of the Township of Haddon, entitled “Rates and Charges,” is hereby amended, revised, and supplemented as follows:

**§ 54-33 Rates and Charges.**

Hourly rates for extra-duty assignments shall be as follows:

- A. [No Changes]
- B. The rate for Haddon Township governmental agencies and bona fide Haddon Township civic associations will be a flat rate of \$125 per employee per outside employment event; and
  - 1. The rates for Haddon Township school events shall be \$75 per hour, and such assignments are not eligible for the four-hour Call-Back provision; and
- C. A charge of 20% of the total costs to be paid to the Township to cover the administrative cost of providing such services; and
  - 1. The Haddon Township School District shall not be required to pay this fee for services provided pursuant to Section 54-33(B)(1); and
- D. [No Changes]

**SECTION 2:** Except as set forth in Section 1 above, the balance of the Code of the Township of Haddon shall not be affected by this Ordinance.

**SECTION 3:** All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

**SECTION 4:** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

**SECTION 5:** This Ordinance shall take effect upon passage and publication according to law.
