Myles Grady, 506 Avondale Avenue – Mr. Grady came to the meeting tonight to follow up on the last meeting and find out where the Township stood regarding safety measures along Crystal Lake Avenue. Chief Cavallo responded that the Police Officers were instructed to go out to Crystal Lake Avenue. Mr. Grady reported that he can attest that they have seen police presence and he very much appreciates the efforts. Mr. Grady wanted to know what more can be done to ramp up safety. Commissioner Mulroy responded that during the summer months the Township will ramp up enforcement. Mr. Grady said he was really interested in the study that was mentioned at the previous meeting. Mayor Teague responded that if the Township does another study, the two studies can be compared to identify any changes. Commissioner Mulroy reported that according to his recollection there was nothing alarming in the earlier report, but certainly if things have changed the Township would want to know that information.

Doug Marshall, 712 Graisbury Avenue – Mr. Marshall came to the meeting to say he appreciates the Township Police showing up and ticketing people going through stop signs. He reported that he was in an automobile accident in Haddon Township when a woman went through a stop sign. She hit him as he was stopped at the stop sign. Mr. Marshall reiterated that the citizens need the Township Police presence out there and he appreciates their presence. He brought up the issue at Target this year with the boys riding through the parking lot with hoods on using vulgarity. Mr. Marshall stated that he feels this leads to unruliness and it needs to be nipped in the bud.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.
