

**ORDINANCE #1468**

**ORDINANCE OF THE TOWNSHIP OF HADDON, COUNTY OF CAMDEN, AND  
STATE OF NEW JERSEY AMENDING AND REVISING CHAPTER 175 OF THE  
CODE OF THE TOWNSHIP OF HADDON ENTITLED “PEACE AND GOOD ORDER”**

**WHEREAS**, Chapter 175 of the Code of the Township of Haddon (the “Township”), entitled “Peace and Good Order,” sets forth miscellaneous provisions that have been determined to be in the best interests of the public health, safety and welfare of the residents of the Township; and

**WHEREAS**, the Township has determined that a restriction on sleeping in vehicles within the Township is desirable and in the best interest of the Township and its citizens; and

**WHEREAS**, pursuant to N.J.S.A. 40:48-2, the Board of Commissioners is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Township by law.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Board of Commissioners of the Township of Haddon, County of Camden, State of New Jersey, as follows:

**SECTION 1:** Chapter 175 of the Code of the Township of Haddon, entitled “Good Order and Peace,” is hereby amended, revised, and supplemented to establish Section 22, “Sleeping in vehicles,” as follows:

**§ 175-22      Sleeping in vehicles.**

It shall be unlawful to sleep in any parked motor vehicle or any other type of vehicle, either day or night, within Township limits.

**SECTION 2:** Except as set forth in Section 1 above, the balance of the Code of the Township of Haddon shall not be affected by this Ordinance.

**SECTION 3:** All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

**SECTION 4:** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

**SECTION 5:** This Ordinance shall take effect upon passage and publication according to law.
